Billie-Jo Kester gave the Treasurer's report. The Town received notice that Wisconsin Pridestone has filed chapter 128. They have a judgment against them to pay 2 years of unpaid personal property. Billie-Jo will check with our lawyer to see how we can collect the money. Spranger has not paid their personal property and has not replied to any letters sent regarding the unpaid bill. The bill will be taken to small claims.

The Board discussed issuing driveway permits in the Town. One driveway per parcel will be allowed. All additional driveways need to be approved by the Board.

Correspondence was read.

Frank made a motion to approve the bills paid. Heeg seconded it. Motion passed.

Passineau made a motion to adjourn the meeting. Heeg seconded it. Motion passed. The meeting adjourned at 7:22 p.m.
