The Board discussed changing the current business permit ordinance. They would like to require business permits for all new and existing businesses within the Town. The Board would like to have the right to revoke a license if a business is not following Town ordinances or if a business owes money to the Town. Possible adoption of the ordinance will be placed on the next regular Town agenda.

The Citizen Economic Committee has had a few meetings. They are looking into the possibility of purchasing some property.

Several residents have contacted the Town regarding water issues along Ranger Road. Many are pumping water out of their basements constantly with the high water table they currently have in their area. Approximately 20 years ago, the water issue was taken up by the Army Corp of Engineers and FEMA. Several houses were raised to help alleviate some of the water problems residents were having back then. Unfortunately houses have been sold to new owners without disclosing that there had been water issues or people built their houses in a dry creek bed that runs along Ranger Road area. People filling in their ditches has also made the water problem worse. There is no easy fix with the high water table in the area with the way the water runs under the ground. Residents are urged to call Wood County Emergency Government to see if there would be any help for them with water in their basements.

Dave Ryun gave the Constable report. Dennis Trickle was sent a letter. He has not cleaned the property and has not submitted a clean-up plan to the Town. He will be sent a citation. Jean Fennel, the responsible party for 1640 Evergreen Avenue was sent a letter to clean the property up and no response has been received. A citation will be issued.

The Board reviewed ATV/UTV Route Ordinance 6-5-19. Forbes made a motion to adopt Ordinance 6-5-19. It changes the current ordinance to add Pine Street, Pine Tree Drive, and Heeg Lane as routes and changes the language for the Hwy 73 route from Church Avenue to Nekoosa City limits as approved by the Wisconsin DOT. Heeg seconded it. Motion passed unanimously.

Billie-Jo Kester gave the Treasurer report. Billie-Jo, Heidi Kawleski, Lorelei Fuehrer, Lisa Havel, and Bill Hall all helped sort and bag garbage and materials at Dean Folts property on Hwy 73 in April. He has continued to make progress on the rest of the clean-up.

Wood County and the Town have been working on dips throughout the Town. They have dug out, removing stumps, and filled 9 with sand. There are 6 more scheduled this year. They plan to pave them later in the fall after they have had time to settle.

Advertising and bids for seal coating Church Avenue from Hwy 13 to County Road Z will be put out and accepted in the next several months.

There is a tree at the corner of 48th and Spruce where the base is looking like it is rotting. The owner of the property would have to cut it down since it isn't in the Towns' right-of-way.

Bill Cahak, owner of Badger Marine is building a shed closer to the lot line then what is allowed. He was told by the Town he would need to move within the specified setbacks before he started building. The Town will check with the Building Inspector to see if a stop work order could be issued.

The Town received information from Botham Ink. Her company spends between 25-40 hours a month on town business. Her hourly rate is \$200/ hour. It is more advantageous to have them on a monthly retainer. With the monthly retainer they can always be ready if there was an immediate need for their services.

Correspondences were read.

Frank made a motion to approve the bills paid. Passineau seconded it. Motion passed unanimously.

Passineau made a motion to adjourn the meeting. Heeg seconded it. Motion passed unanimously. The meeting adjourned at 7:14 p.m.
