ATTENTION ALL DOG OWNERS- DOG LICENSE DUE DATE IS MARCH 31, 2021

Dogs more than 5 months old within the license year must obtain a dog license. All dogs must be inoculated for Rabies and must be licensed under penalty of law. (ss. 174.05 (10)). No license will be issued without proof of rabies inoculation certificate. Licenses are due MARCH 31, 2021. (Late fee applies.) \$15 late fee will be given to anyone getting a 5-day ticket for not having their dog licensed.

You MUST have the rabies certificate for each dog with your current mailing address written on it. PLEASE SEND RABIES CERTIFICATE ALONG WITH PAYMENT TO: (or leave with the bank with tax payment) Town of Saratoga 1120 St. Hwy 73 So. Wisconsin Rapids WI 54494

LICENSE FEES are: Spayed Female/Neutered Male \$3.00 (If late, add \$15 per each dog)

Multiple (1 to 12 dogs)

\$8.00 (If late, **add** \$15 per each dog) \$35.00 + \$3.00 over 12. (If late, **add** \$15)

Citations will be issued to dog owners or keepers of unlicensed and/or dogs running at large When using the mail or the bank listed above, the rabies certificates & license will be mailed back to you. PLEASE LET ME KNOW IF YOU NO LONGER HAVE A DOG THAT WAS LICENSED IN 2020.

A do-not-resuscitate bracelet that has <u>not been removed</u>, altered, or tampered with in any way shall be presumed valid, unless the patient, the patient's guardian, or the patient's health care agent expresses to the emergency medical services practitioner, emergency medical responder, or emergency health care facility personnel the patient's desire to be resuscitated.

DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT????

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible.

To Qualify:

You must own a home in Wisconsin.

AND:

Your home must have been occupied as a PRIMARY residence on January 1, 2020.

- A. A primary residence is the home in which a property owner lives for more than six months of the year.
- B. If temporarily away, a primary residence is the home to which the owner returns.

If you feel you qualify for the credit and there is not a lottery credit on your tax bill, go to

Fill it out, then print the document and send it in with your payment prior to February 1, 2021.

Ordinance No. 11-27-2007, Town of Saratoga, Wood County-

Section 1 A. Winter Parking Restrictions:

- a. During the period of November 1 through April 15, it shall be unlawful to park any vehicle on the town road right-of-way. Any vehicle found parked upon the town road right-of-way during this time period may be towed, at the owner's expense, if the Town Road Lead man and/or Town Board Member shall deem necessary for the health and safety of the residents of the Town of Saratoga.
- b. Penalties shall apply as referenced in 11-27-2007.

It is unlawful to plow snow on to the road right-of-way or across the road according to Wis. Statute 346.94(5).

The Town of Saratoga is not responsible for mail boxes that get damaged or knocked over by the snowplows.
