

Ordinance 2-21-24

**ORDINANCE FOR WARD DIVISION AND DESIGNATING A POLLING PLACE**

Town of Saratoga  
State of Wisconsin, Wood County

WHEREAS, the Town of Saratoga, Wood County, Wisconsin, is responsible for ward division and designating polling places in the Town of Saratoga, and

WHEREAS, on the 21<sup>st</sup> of March, 2012, the Town Board of the Town of Saratoga made and passed a motion to separate the Town of Saratoga into wards,

NOW, THEREFORE BE IT RESOLVED by the Town Board of the Town of Saratoga that the town be divided into eight wards as follows:

WARD 1: Township 21 North, Range 5 East: Bounded by the Wisconsin River on West, Church Avenue on the North, Hollywood Road and County Road Z on the East, and County line on South.

WARD 2: Beginning point at intersection of Hollywood Road and Hwy 73 South - East to the N 1/4 corner of section 17 (Township 21 North, Range 6 E), S along 1/4 section line to the Adams County line, W on Adams County line to County Trunk Z, N on County Trunk Z and Hollywood Road to point of beginning.

WARD 3: Bound on the W and N by the Wisconsin River to the E 1/2 of NE 1/4 of section 1 (Township 21, Range 5 E), S to S line of NE 1/4, E to County Trunk Z to Ranger Road, E to the N 1/4 corner of section 8 (Township 21, Range 6 E), S to Hwy 73, W to Hollywood Rd, N to Church Ave, W to Wisconsin River.

WARD 4: Beginning point at intersection of Ranger Road and County Trunk Z - N on County Trunk Z to the S line of the E 1/2 to NE 1/4 of section 1 (Township 21, Range 5 E), W to the W line of the E 1/2 of the NE 1/4, N to town line, E on town line to the NE corner of section 6 (Township 21, Range 6 E), S on section line to Ranger Road, W on Ranger Road to point of beginning. Excluding the S 1/2 of the SE 1/4 of the NE 1/4.

WARD 5: Township 21 North, Range 6 E: Beginning point of intersection of Church Avenue and Hwy 13 - N to Ranger Road, W to SE corner of section 6, N to Townline Road, E to utility corridor in section 3, S on utility corridor to 28th Street, S on 28th Street to Church Avenue, W to point of beginning. Including the S 1/2 of the SE of the NE.

WARD 6: Township 21 North, Range 6 E: Beginning at utility corridor in section 3 - E on Townline to 64th Street, S to Church Avenue, W to 28th Street, N on 28th to utility corridor, N to Townline Road.

WARD 7: Township 21 North, Range 6 E: Beginning point at intersection of Townline Road and 64<sup>th</sup> Street - E to County Trunk U, S to Evergreen Avenue, W to Hwy 13 S, N to Hasa Ln., W to utility corridor, SW along said corridor to a point along the Nekoosa

school district boundary line. N on said line to Ranger Road, E to Hwy 13 S, South to Church Avenue, E to 64<sup>th</sup>, N to beginning point.

WARD 8: Township 21 North, Range 6 E: Beginning point at intersection of Evergreen Avenue and County Trunk U - S to County line, W to W line of SE ¼ of section 32, N on said line to intersection of utility corridor, NE along said corridor to Hasa Ln., E to Hwy 13 S, S to Evergreen Avenue, E to point of beginning.

Wards 1, 2, 3 and of 4 are in the Nekoosa School District.  
Wards 5, 6, 7 and 8 are in the Wisconsin Rapids School District.


BE IT FURTHER RESOLVED that the polling place in the Town of Saratoga for all wards will be the Saratoga Town hall.


