**One & Two Family Dwellings – New Structures and Additions – Including Camping Units in Campgrounds**

Construction (\$75.00 minimum) -----	\$0.12 per square foot
Mechanicals	
Electrical-----	\$.05 per square foot
Plumbing-----	\$.05 per square foot
HVAC-----	\$.05 per square foot
State of Wisconsin (State Seal) -----	\$38.00
Camping Unit insignia-----	\$35.00
Early Start (Footing and Foundation only) -----	\$55.00

Note: Fees for manufactured dwellings with a Wisconsin Insignia affixed shall be 2/3 of the normal fee for any closed-panel manufacturing area and full fee for site-built areas.

**One & Two Family Dwellings – Alterations**

\$50.00 minimum - \$5.50 per thousand of estimated cost (mechanicals \$35.00 each)

**Accessory Structures – Detached garages, pole buildings, and sheds (over 100 Sq. foot)**

Construction (\$50.00 minimum) -----	\$.12 per square foot per floor

Plumbing permit (water heater replacement)-----	\$35.00
HVAC permit (Furnace & A/C Replacements) -----	\$55.00
