General Information About Your Property Tax

When are my taxes due?

Your entire real estate tax bill, or your first installment, is **due by January 31**, **2025**. If you choose to pay in installments, your first installment is due by January 31, 2025 and your second installment in due by July 31, 2025. Make note that the amount of your installments may vary. If you fail to pay the correct amount, at the correct time, to the correct place it will cause you to incur additional charges.

Where do I pay?

All payments made on or before January 31, 2025, must be paid to:

What happens if I pay late?

By State law, if you fail to pay the entire amount of your first installment by January 31, 2025 then the option to pay in installments is no longer available. The entire balance then becomes due and will accrue interest at a rate of 1.0% per month until the delinquent amount is paid in full.

Payments postmarked December 31 will be processed for December. Payments postmarked January 31 are accepted as being on time.

Returned Non-sufficient fund checks will be charged \$35.00 plus bank charges.

How can I pay?

You have several options to make the tax payment that is due by January 31st, 2025 and get the 2025 dog license that is due by March 31, 2025.

What if I can't pay my entire 1st installment amount?

We encourage everyone to try and pay at least the amount of their first installment to avoid interest and penalty. It is in your best interest to pay as much as you can by the due date. Continuing to make monthly payments until your entire balance is paid in full will help to reduce the amount of interest and penalty you will pay and reduce the risk of losing your property.

Where is my refund?

Overpayments of less than \$5.00 will be refunded only upon written request. Cash refunds are not given. Refund checks will be issued after your/mortgage check has cleared all banks. This may take up to thirty days. Request your bank/mortgage company to cut you a separate check for the amount over your tax payment.

How are my taxes calculated?

Your tax amount is derived by multiplying the value of your property as of January 1, 2024 and the mil I rate for all the taxing jurisdictions, then subtracting any applicable credits and adding any special assessments, special charges, or special taxes. The amount of your taxes cannot change unless there was an error in the application of one of those items.

The Town of Saratoga is <u>not responsible</u> for mail boxes that get damaged or knocked over by the snowplows due to the weight of the snow.

It is <u>unlawful to plow snow on to the road right-of-way or across the road</u> according to Wis. Statute 346.94(5). Ordinance No. 11-27-2007, Town of Saratoga, Wood County- Section 1 A. <u>Winter Parking Restrictions</u>:

a. During the period of November 1 through April 15, it shall be unlawful to park any vehicle on the town road right-of-way. Any vehicle found parked upon the town road right-of-way during this time period may be towed, at the owner's expense, if the Town Road Lead man and/or Town Board Member shall deem necessary for the health and safety of the residents of the Town of Saratoga. Penalties shall apply as referenced in 11-27-2007.

Town Collection Sites

Transfer site: 9642 Cty Rd Z south, Nekoosa: Open 2nd and last Saturday each month April through October. Tires accepted: up to 10 tires 20 inches or less per address, per year with no fee.

Residents owning more than one property in the Town will only be allowed 10 tires total free of charge, any over the 10 will be charged. All tires taken are at the discretion of the Town employees.

Other tires and over the 10 limit: Fees as follows: 20" or less-\$5 each, Tires over 20" up to Farm Tractor Tires \$15 each, Farm Tractor Tires \$20 each. All tires must be off the rim.

Brush site: 12799 Hollywood Road, Nekoosa: Open the 3rd Saturday each month April through October from 8:00A.M.-12:00P.M. Only Saratoga residents (Not Commercial businesses) are allowed to use the site. **Identification will be checked at Transfer and Brush sites to confirm Town residency.**

City of Wisconsin Rapids Yard Waste Site

Yard Waste: Residents of the Town of Saratoga may purchase an annual permit for the Wisconsin Rapids Compost Site for \$65. Permits may be purchased from the Saratoga Mini Mart, (8810 Hwy 13 South, Wisconsin Rapids) or from the City of Wisconsin Rapids garage (1411 Chase Street, Wisconsin Rapids). Garbage Collection: Waste Management (WM)

Garbage & Recycling Containers may NOT be on the road.

Required placement is 3 feet from the road and the containers should be a minimum of 1 foot apart.

Town residents are required to use the containers provided by WM for their garbage & recycling.

DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT????

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible.

To Qualify: You m

You must own a home in Wisconsin.

AND:

Your home must have been occupied as your PRIMARY residence on January 1, 2024.

- A. A primary residence is the home in which a property owner lives for more than six months of the year.
- B. If temporarily away, a primary residence is the home to which the owner returns.
